



# RAFFLE TERMS AND CONDITIONS 2025 ABSC Fundraising Raffles

# **RESPONSIBLE ORGANISATION AND BENEFICIARY**

This raffle is conducted by Snooker & Billiards NSW Inc. (SBNSW). The sole beneficiary of the raffle is the Australian Billiards & Snooker Council Ltd (ABSC), a not-for-profit organisation which will use the proceeds to fund the ABSC's development programs, including Player Support, National Championships, Live Streaming, Referees, and Technology.

#### **TICKETS**

There will be a maximum of 100 tickets available for purchase at a cost set individually for each raffle.

#### **TICKET SALES**

Tickets will only be available for purchase via the SBNSW and ABSC websites, using a credit / debit card. Cash sales or EFT will not be available.

Tickets will be issued sequentially, and there is no option to select a particular ticket number.

Tickets will be issued electronically via email as a PDF document, and each ticket will contain the following information:

- Raffle Identifier
- Ticket Number
- Name of purchaser
- Contact email / phone of purchaser
- Ticket Price
- Raffle Terms & Conditions

# **RAFFLE OPENING AND CLOSING DATES**

Tickets will be available for purchase through the SBNSW and ABSC websites from between the dates advertised for each raffle. Ticket sales will cease at the earlier than the advertised closing date if all 100 tickets are sold.

#### **PRIZES AND VALUE**

There will be three cash prizes drawn. The prize pool will be set at 50% of the value of all tickets sold - e.g. for 100 tickets at \$50 each the prize pool will be \$2500. In this case, if all 100 tickets are sold the prize values will be:

First Prize: \$1250

Second Prize: \$750

Third Prize: \$500





<u>If less than all 100 tickets are sold</u> each prize will be reduced proportionately in value. <u>For example</u>, if 80 tickets are sold, the prizes will be:

First Prize: \$1250 \* 80/100 = \$1000

**Second Prize**: \$750 \* 80/100 = \$600

Third Prize: \$500 \* 80/100 = \$400

Each ticket is only eligible to win one prize.

The value of all prizes is expressed in Australian dollars (AUD).

# TIME & DATE OF DRAW

The Prize draw will take place at the time advertised for each raffle. The draw will be conducted electronically by the independent service provider RandomDraws (<a href="https://www.randomdraws.com.au/">https://www.randomdraws.com.au/</a>), and winning ticket numbers will be announced as soon as available.

#### **NOTIFICATION OF PRIZE WINNERS**

Prize winners will be notified within two days of the draw taking place by email and phone (if provided). The names of all prize winners will also be posted on SBNSW and ABSC websites and Facebook pages

#### **HANDLING OF UNCLAIMED PRIZES**

Any prize which remains unclaimed after 3 months from the time of the prize draw will be re-drawn at a time and place, and by a method to be determined by the SBNSW. The redraw conditions will be posted on SBNSW and ABSC websites and Facebook pages one month before the redraw is to take place.

# **PRIZES FOR OVERSEAS RESIDENTS**

The cash component of each prize will be payable to the winner's nominated bank account in their local currency, based on the prevailing currency exchange rate.

SBNSW will contact all overseas winners directly to ensure the most appropriate arrangements for the receipt of prizes.
